

In the Matter of Amending the  
Plumbing Code Schedule of Fees

ORDINANCE NO. 03-08

THE VILLAGE BOARD OF THE VILLAGE OF BROWN DEER DO HEREBY ORDAIN AS FOLLOWS:

SECTION I. REPEAL. Section 1-1.04 (A) of the Schedule of Fees, of the Plumbing Code, Volume II of the Brown Deer Village Code, is hereby repealed.

SECTION II. RECREATION. Section 1-1.04 (A) of the Schedule of Fees, of the Plumbing Code, Volume II of the Brown Deer Village Code is hereby recreated to read as follows:

(A) The schedule of fees to be paid under the provisions of this Code shall be as follows:

SECTION III. PENALTY. Any plumber, property owner, or other person found guilty of violating any of the provisions of this Code, or of installing or allowing to be installed any plumbing of this drainage in the Village of Brown Deer contrary to the provisions of this Code, shall be subject to a fine of not less than one (\$1.00) dollar, and not more than two hundred (\$200.00) dollars, together with the costs of prosecution; and in default of payment thereof shall be imprisoned in the County Jail or the House of Correction of Milwaukee County until said fine and costs, together with subsequent costs, are paid, but in any event not to exceed sixty (60) days. Each day of violation shall constitute a separate offense.
