**I. ROLL CALL**

*It was moved by Commissioner Allen, and seconded by Commissioner Lowder to approve the promotional procedure for Police Lieutenant as outlined in COP 2010-015. The motion carried unanimously.*

*It was moved by Commissioner Williams, and seconded by Commissioner Kust to approve the recruitment procedure for Desk and Patrol Officer as outlined in COP 2010-017. The motion carried unanimously.*
