Noteworthy Calls for the Day

Operating While Intoxicated – 4300blk W Bradley Rd

An unidentified caller reported that a black SUV was parked in the driveway to the underground garage playing loud music. The driver, a 36 year old female resident, was arrested for Operating While Intoxicated – 2nd Offense and two outstanding warrants through our department. The female was conveyed to the station, booked, and transported to the Milwaukee County Jail. A report was filed.

Auto Lockout – 5100blk W Brown Deer Rd

A 22 year old Milwaukee male called 911 because he locked his keys in his running vehicle. The male was offered a ride to his place of employment and offered numbers to locksmith services, but declined both. The male called 911 again because he was upset that he was locked out of his car and had no money. Dispatch and employees inside the business advised that the male was yelling. He was advised about his language inside the store and was advised that if he called 911 again he would be cited.

Vehicle Crash – N Teutonia Ave/W Dean Rd

Report of a vehicle crash in the intersection. A 90 year old female resident and a 26 year old Milwaukee male were involved. The female failed to yield the right-of-way while making a left turn, causing the accident. The male was arrested for an outstanding warrant with our department and Possession of a Controlled Substance - THC. The male was conveyed to the station, booked, and cited. A 58 year old female resident requested police assistance. The female stated that her husband was an international oil driller and was currently in Ghana. She advised that he sent her \$3.5 million to O'Hare Airport, but the company who was holding the money now wanted her to send \$8,500 to get a certificate to retrieve the money. It was determined that the female had only talked with her husband via Skype, they had never met in person, and she had already wired \$20,000 overseas. She was advised that it was a scam and to stop sending money to anyone. A report was filed.
