## **STORAGE SHEDS**

### **A BUILDING PERMIT IS REQUIRED**

**Fees are as follows:**

**Up to 200 sq. ft. - \$85.00 (Includes plan review)**  
**200 to 400 sq. ft. - \$0.32 sq. ft. "plus" a \$60.00 plan review**

A storage shed may be constructed providing the following criteria are met:

- Sheds may only be constructed in the rear and interior side yards. This means that a shed **may not** be constructed in front of your home or, if located on a corner, a shed **may not** be constructed in the side yard of your home that adjoins the street.
- Sheds **may not** be constructed within any easement. (See plat of survey to determine if you have an easement.)
- Maximum size - 400 sq. ft. - The shed cannot be more than the principle structure or 15' in height, whichever is lower. **Anything over 200 sq. ft. requires Village of Brown Deer Architectural Building Board approval and a separate review fee of \$60.00.**
- Minimum distance from other buildings, i.e. house, garage - 10'
- Minimum distance from lot line - 5'
- A plan, drawn to scale no smaller than 1/4" = 1', or, if building from a kit, a copy of the manufacturer's specifications for construction must be submitted with the Building Permit application.
- The location of the shed must be indicated on a copy of the Plat of Survey for your property.
- Construction must be according to the manufacturer's specifications when a kit is being used or meet the minimum standards of the Wisconsin Uniform Dwelling Code when building from your own plan.
- The storage shed must be constructed on a floating or footed slab of reinforced concrete not less than 4" in thickness, or a treated wood floor system. Dirt, gravel or sand floor is not permitted.

## **Shed Application Requirements**

Village Code Section 121

---

**The Village of Brown Deer Architectural Building Board reviews all shed submittals "OVER" 200 sq. ft., and PRIOR to the issuance of the Building Permit by the Building Inspector.**

---

**The information below is a required minimum & other materials may be requested of the applicant during the review process.**

- A complete application along with a **\$60.00 non-refundable Architectural Building Board Review fee** & supporting materials including (**ALL SAMPLES & COLORS OF THE MATERIALS TO BE USED**) shall be submitted by 4:30 pm on the Tuesday before the next scheduled meeting.

**The Architectural Building Board meets on the 1st and 3rd Monday of each month at 4:00 pm in the Earl McGovern Board room.**

- Three (3) copies of the shed in a dimensional scale drawing form, no smaller than 1/4"=1"-0" with the architectural style, all colors in sample form, and **samples** of all materials to be used.

**A colored rendering or brochure and color samples with identifying brand & color code numbers must be submitted with application.**

- Three (3) copies of a plat of survey or scaled drawing of your property indicating the location & position of the shed in relation to the nearby structures, property.
- Three (3) copies of a color rendering or digital photographs of the existing and adjacent premises, building to help assist the Architectural Building Board in making aesthetic decisions.
- Meetings falling on a holiday will not be rescheduled.

**It is strongly recommended that someone representing the submittal be present at the Architectural Building Board meeting.**

**The plans may be denied or laid over if ALL DETAILS and ALL MATERIAL SAMPLES cannot be clarified at the time of the meeting.**
