Juvenile Complaint - Mobil

At 7:54 PM staff reported that a known group of juveniles ate a bag of chips while inside the store and have caused problems in the past. The general manager only wanted the subjects trespassed from the store. The juveniles, an 11 year old male resident, a 13 year old male resident and a nine year old male resident, were located at Brook Lane Apartments. They were advised that they are not allowed at Mobil.

Family Trouble – Brook Lane Apartments

At 8:05 PM a 33 year old female resident requested that officers bring her 11 year old son home after he left without her permission. The juvenile was located with a 13 year old male resident. Both juveniles were turned over to their parents.
